Hi Jennifer,

I have no issues with any of the planting locations you've proposed. I've added a few others to the plan (red circles on the attached image). Is there any reason trees can't go in these locations as well?

Here's what I suggest. Plant 3 inch caliper stock. I have species suggestions in the attached image. Regardless of what is planted, all trees must be native to Michigan. If you would like to plant additional trees in a Park, to reduce the cost that would be due to the Tree Fund, I will reach out to the Park's Landscape Architect. She would have to approve any plantings to take place there.

Here are how the numbers work out based on what you submitted to me vs. adding the trees I suggested.

Required Mitigation: 126 inches Payment cost per caliper inch: \$200.00

Required to be planted on site: 63 inches

Let me know what you think of this and we can go from here. Once we settle on a plan moving forward, you will need to update your landscape plan and natural features plan. Those will be incorporated into the plan set and sent forward to the Planning Commission.
